Rules and Guidelines

- **A vender will receive one vender pass which must be displayed in the upper left corner of the automobile windshield. A vender may set up between 8 a.m. and 10 a.m and may park in nearby parking.**
- **Tents or canopies must be weighted down to sustain themselves in Oklahoma wind and weather. Please post a sign (not on the walkway) on your booth.**
- **Each vender must collect Oklahoma state and Bethany sales tax (8.5 percent) and remit it to the Oklahoma Tax Commission under Bethany code number 5504.**
- **Bethany 66 Festival assumes no responsibility for personal injury, damage to or loss of personal property by vender. Each vender agrees to indemnify and hold harmless Bethany 66 Festival, Bethany Development Authority, the City of Bethany and all event sponsors and organizers with respect to any and all aspects of its operations of said booths.**
- **Vendors cannot sell food or drinks.**
- **No items may be given away without prior approval of event organizers.**
- **Vendors will clean up and remove trash from their areas.**
- **Tear-down shall begin at 5 p.m.**
- **Each vender agrees to comply with any and all applicable state, city, county and federal laws and regulations pertaining to the operation of its business in the booth including, without limitations, fire regulations and state and county health codes.**
- **No possession or sale of beer, intoxicating beverages or intoxicating chemicals will be permitted.**
- **Violation of rules and guidelines can result in a vender being asked to leave the event as well as resulting loss of fees. A vender signature at the bottom of Page 2 indicates acceptance of these rules and guidelines.**
- **Organizers reserve the right to decline acceptance of a vender.**
